Aims and Objectives:

Earlston Community Development Trust (ECDT) is a legally constituted voluntary organisation and is run by members of the Earlston community. Registered as a Scottish Charitable Incorporated Organisation (SCIO) whose constitution was signed 26th January 2012.

Charitable Purposes:

- The advancement of citizenship or community development.
- The provision of recreational facilities, or the organisation of recreational activities, with the object of improving the conditions of life for the person for whom the facilities or activities are primarily intended.
- The advancement of environmental protection or improvement.

Summary of Main Activities in relation to objectives:

Our aim is to help the village of Earlston develop facilities that can be owned and managed by the people of Earlston for the benefit of the whole community.

Our goals are to provide services and facilities for recreation and other leisure time facilities for the Earlston area following principles of sustainable development and in the interests of social welfare so that local people's conditions of life may be improved; and to provide an example of best practice for similar organisation's both regionally and nationally.

Mission Statement:

"To meet the social, cultural, environmental, educational and other needs of the communities of the Earlston Area (Earlston and surrounding communities) by providing facilities, services and carrying out other relevant activities. The Trust will be run by the people of Earlston area for the people of Earlston area"

Charitable activities to 30th November 2015:

Community Day:

Due to the imminent opening of the new Borders Railway Line, this year's Community Day had a railway theme to it which proved to be very popular and lots of fun. This was kindly supported by a grant from the SBC Borders Railway Celebration Fund.



There was also a wonderful display of photographs of Earlston's old train station and railway in action kindly provided by Auld Earlston.

This year's activities, as always, started with a special Community Day Service at Earlston Church. The Rugby Club was the next stop where events started off with the community bike ride out. Cycle speedway racing was introduced this year where four riders battled it out, side by side, over sprint laps and a number of heats to decide the winner.

Once again, there was a variety of different community groups showcasing their work, providing information about their group, promoting new membership and offering different activities to try.

Due to popular demand and continuing support from Reiver Recruitment, the Smoothie Bike was back and busier than ever. This year we asked for donations for the maintenance costs for Earlston's Defibrillator and we are delighted to say that £30.73 was raised. The majority of these donations came from the young people enjoying their healthy smoothies - well done guys!

We had fantastic live music this year from the Ukulele Club and local band, General Tailors. The tug-of-war competition saw the Dangerous Divas team become the new champions and were presented with the Cup donated by BSW Timber.

In addition there was a raffle with over 40 fabulous prizes, generously donated by local businesses/individuals, whom every year never cease to amaze us.

Orchard Town Project

Over the past year there has been ongoing work weeding and pruning and this year, again, saw some trees bearing fruit.

The next phase of this project is to plant fruit trees in and around the town, which is central urban planting. We have identified green spaces owned by Scottish Borders Housing Association (SBHA) and after consultation with them they are supportive of our plans. We had hoped to have started this but due to the resources needed for the Play Park Project this was put on hold. During the next year we will be carrying out further consultation exercises with the community and applying for grant funding to enable us to take this phase forward.

Play Park:

As detailed in our last Annual Report, in December 2014 the Big Lottery decided to award a grant of £250,000 on the condition that we:

- 1) Provide written confirmation that the (matched/additional) funding was in place.
- 2) Prior to starting the grant provide confirmation that the project enjoys appropriate community support that enables successful delivery of the project.

To meet the second condition of the grant offer we devised a community engagement plan to ensure everyone was fully informed of the project and confirm community support. To deliver the engagement plan over the year we:

- Produced two information newsletters which were delivered by volunteers to each household
- Responded to a document which had 106 questions, further questions generated from our answers to the initial document and various letters from individuals
- Held two community events
- Contacted Community Groups in the village to see if they would like us to attend one of their meetings to discuss Mill Meadow play park project

In agreement with the BIG Lottery Fund, and to complete the Community Engagement Plan, a formal postal ballot was held during August/September to ask the community to confirm whether they supported a play park at Mill Meadow. Two further ballots were also held at the High School and Primary School to obtain young people's views.

The results of this ballot was as follows:

Number eligible to vote: 1,880

Votes cast: 1,190 Invalid Votes: 9 Votes For: 314 Votes Against: 867

The results of two school ballots were:

Votes cast - 152

Abstentions - 13

Unclear - 1

Blank - 3

Yes - 101

No - 47

High School Ballot:

Votes cast - 118

Abstentions - 2

Unclear - 0

Blank - 2

Yes - 50

No - 66

As the majority of the community voted against developing a play park at Mill Meadow, the final condition of the grant award could not be met. The play park project is, therefore, now finished and all grants have been terminated. We would like to take this opportunity to

thank our volunteers, supporters, Scottish Borders Council and the Big Lottery for all their support and help throughout the project, it has been very much appreciated.


